

# Green Walkable Streets Artwork Project

## Terms and Conditions

- Submissions are open from Wednesday 30 December 2022 to Wednesday 18 January 2023.
- Submissions are open to Ipswich residents or those who work or study in the Ipswich local government area.
- Submissions can be made as an individual or as a group.
- The submission must include:
  - the design (60%)
  - the artwork statement (250 words) (20%)
  - the artist statement (50 words)
  - response to green theme (20%)
  - signed parental consent form if under 18 years of age
  - supporting documentation to demonstrate whether the applicant is a resident, student or employee in the region.
- All submission should be made through [ipswichcentral.com.au](https://ipswichcentral.com.au).
- Any artist who wishes to withdraw their submission from the project before the closing date of Wednesday 18 January 2023 can do so by notifying us in writing at [business@ipswich.qld.gov.au](mailto:business@ipswich.qld.gov.au).
- All submissions will be reviewed by a panel of Ipswich City Council staff and a minimum of one (1) external representative. The panel will assess based off the criteria outlined.
- The chosen artists will have their art reproduced and then wrapped on an identified Energex box in Ipswich Central.
- All artists will be notified by email, whether they have been selected or not.
- Each submission selected by the judges for installation will receive a \$250 gift card.
- If the design is submitted as a group, there is only one prize of a \$250 gift card to be shared.
- Council will bear the costs associated with installation of the artwork on the Energex asset.
- The art will be displayed for a minimum of 12 months.
- All chosen artwork designs, including the artist statement, will be hosted and displayed on [ipswichcentral.com.au](https://ipswichcentral.com.au) and may be shared on council's social media platforms.
- If requested, council will publish the artwork anonymously.
- Artwork must be entirely the work of the submitter and must not have been published in print or online or have won a prize in another art project.
- Any submission found to include plagiarised elements or if the work is a reimagination of a common theme the submission will be disqualified.
- The artist has no rights of claim or ownership of the artwork on the Energex Asset.
- Artists retain the copyright of their work and agree to grant Ipswich City Council an irrevocable non-lapsing licence to use, reproduce and publish their artwork.
- The artist gives Energex an unconditional irrevocable licence to use, reproduce and publish as part of their marketing materials.
- Artists agree to allow Ipswich City Council to use the artwork in the media, including but not limited to photographs, videos and social media and may use the artwork in future marketing/promotional materials. Submitting artwork implies an acceptance of the terms and conditions.
- Submissions that fail to comply with the terms and conditions may be disqualified.
- Ipswich City Council reserves the right to suspend or postpone the project if an inadequate amount of submissions are received. Any submissions that were already received may be used in a future project.

### Under 18

- Any participant under the age of 18 must have parental consent to enter.
- The artist's parent or guardian warrants that the work submitted is original and does not infringe the copyright, moral rights or other rights of any third party, and that the artist owns all the rights and interests in the work submitted, and they have their parent or guardian's permission to enter the competition.
- Failure to provide a parent or guardian's consent may deem the submission ineligible.
