

Developing council's Natural Environment Strategy

The story so far

Introduction

A healthy natural environment is important to council and the community. It enhances the liveability of the city and is important to our wellbeing.

After an extensive process of research and consultation, council endorsed its Natural Environment Policy in September 2021. Providing rules for planning and decision making, the purpose of the policy is to strengthen council's commitment to conserve, protect, enhance and restore the natural environment and its value.

Feedback gathered from the community over the past two years has helped us map the current situation, understand community concerns and identify future trends. This data will be used in the development of the Natural Environment Strategy which will shape the natural environment of Ipswich into the future.

<p>iFuture</p> 	<p>Community said that they wanted a "natural and sustainable" theme included as a key theme for the plan.</p>	<p>The Natural and Sustainable theme has been incorporated into iFuture with a number of catalyst projects to be achieved in the next five years.</p>

The next step is to develop the strategy together. This will guide how the Policy is put into practice to provide a corporate approach to conserve, protect, enhance and restore the health of the city's natural environment values. It will provide a roadmap to help ensure:

- the city is greener and more connected
- council and the city are prepared to face future environmental challenges
- council continues its commitment to conserve and restore the city's natural environment through implementing its corporate responsibilities and provision of services to the community.
